Your BLPA Board of Directors, along with the Ecology Committee, has been studying the prospect of adding alum to the lakes to restore the water clarity that we enjoyed just a few years ago. We have attended an Alum Workshop in Madison WI, sponsored by the North American Lake Management Society (at no cost to the BLPA), consulted with Dr. Dan Canfield with Lakewatch, and we have gotten some estimates from a consultant. So far, it looks very doable and very economical.

One low cost dose of alum will instantly double our water clarity! That kind of water clarity will significantly boost our property values. And not just the values of the lakefront residents either. The value of a property with deeded access will also shoot up as the Bear Lakes become known as the cleanest lakes in Central Florida. Actually, everyone in the watershed will benefit in the form of property appreciation. Have I mentioned that we will get to enjoy the super clean lakes until we think about moving?

The cost can take two forms. The first method is to spend a little and get only one or two years improvement. The second is to spend a lot more and get as much as 10 years improvement. With about 250 homes around Bear Lake alone, the first, where we'd only get one or two years of improvement, would only cost each resident about \$200. The long-term treatment would cost about \$1,200 each. (The long-term treatment uses a lot more alum so that it will be in place when the phosphorous either comes in from the watershed or comes out of the

lake bottom.) We plan to make a recommendation very soon on which method we think is best. No permit is required and we can add the alum at any time; however, the Spring would be best, while the water is the clearest.

Alum is the same thing you buy at the grocery store spice rack for making pickles and other edible foods. It will not harm the fish, animals, or the environment. It is perfectly safe. The City of Winter Park and Orlando have used it for years. We would probably order a tanker truck load of liquid alum and then have it sprayed on the lake's surface. As it falls to the bottom it will lock up all the phosphorous it comes in contact with then it will blend in with the bottom sand and sediment. Come to the next BLPA meeting to learn more.

SAVE A LAKE Our Position: New Fertilizer Restrictions Won't Succeed Without Strong Campaign for Them

Beautify your lawn; harm a lake. That's the lousy trade-off in Florida, where property owners and others spread fertilizer over thousands of acres, only to see it leach into waterways, polluting them.

Sadder still is that one of the fertilizer's most potent polluting agents is unnecessary in maintaining a healthy looking lawn.

Thankfully, the state of Florida appears ready to better the landscape. In April, it's expected to impose its first statewide restriction on fertilizing yards. It may amount to changing some fertilizer formulas, limiting fertilizers containing some phosphorous to new lawns, and instructing those maintaining established lawns to use phosphorous-free fertilizer.

That's a start, but more is needed. An effective education campaign is essential

so property owners will understand the benefits of using phosphorous-free fertilizer. Or, that they can use less fertilizer in growing new yards.

The state also needs to make more headway in limiting threats from agriculture to lakes and wetlands. The coming restrictions apply only to non-agricultural users.

Some progress is being made. Farmers in few counties are using time-release fertilizers that result in less nitrogen penetrating the soil for potato and cabbage crops. That lessens the chances of it making its way to nearby rivers and lakes, where it nurtures algae.

But the state should do still more to further research that can lead to other, less threatening fertilizer applications for other crops. And then to get farmers, like other users, to see their worth.
