Board of Directors Election Scheduled at Meeting on March 10, 2009

The 2009 election of the BLPA Board of Directors will take place at the General Meeting on March 10, 2009, at 7:30 p.m. at St. Andrews Presbyterian Church.

You may also vote by mail. Use the ballot on this page and mail it in an envelope with your name and return address to Bear Lake Preservation Association, PO Box 162605, Altamonte Springs, FL 32716. Ballots must be postmarked no later than March 9, 2009.

After the ballots are in, all ballots, both absentee and those cast at the meeting, will be counted by a non-board member. There is only one vote per qualifying household (husband and wife owners may only vote once on the same ballot).

The BLPA would like to have as many interested, active Board members as possible (for a maximum of 11, minimum of 7) to share the respon-

sibility of maintaining the integrity of the association.

If you know of someone who would be willing to serve, including yourself, write his or her name in one of the write-in candidate spaces on the ballot and place a check mark in front of it.

The time commitment required of Board members is not substantial. (Homemakers and retirees make excellent board members.) Any questions about what is required, please call Corrie Hungerford at 407-947-2901.




Construction Update

Our Feathered "Sandy" Friend...

I got a close up look of the left wing of the heron this morning. "Sandy" is what I call her, and there is a hook embedded in the joint of the wing. She can fly and forage for herself but that wing may get an infec-

tion over time. When she is standing in the water the wing sags. I fed her a few blue gills just to make sure she is

getting food. The algae is so thick that I don't know how they see through it to catch a fish.

Please be cautious perils of leaving rods and reels sticking up on docks that have hooks exposed. I know I see them around all the time. Birds can fly into them and get hooked. These herons even fly around the docks at night. Not sure this is the case for Sandy but it could be. Another reason not to leave them there is that UV and heat weakens the line and if they use them after several days exposure and hook a nice sized fish it will likely break off and oh don't we hate when that happens.

BLPA is applying for 501(c)(3) tax exemption status which, if granted, will make future donations to the alum and lakes management funds tax deductible for most people. We will keep you informed on the status of our application.

Bob and I took many adventure trips over the years starting out with an ocean trip in a 22' open boat to the Bahamas and then two ocean trips to Haiti in the same boat. It had one outboard motor. I came to know who Bob really was during those trips as we encountered some very perilous moments, as you can well imagine. I realized that this guy was bullet proof; being calmer than anyone I had ever known in tense moments.

We then started flying Ultralight airplanes together and made many trips including originating from Bear Lake over the Caribbean and all the way to the Amazon. There was another trip following the Lewis and Clark route out west and over the Rocky Mountains. There were motorcycle trips in Europe and New Zealand all with the same adventurous spirit. I realized that there was no one else who I wanted to be with on these trips. My life was in Bob's hands many times and there is no one else I would have trusted. He was always the calming spirit which I needed on many occasions. Telling stories about all of these trips would take too much time, and you already know that he was a very capable, incredible guy. I think one thing that kind of sums up what kind of guy Bob was is the fact that he was a Navy Seal. If you knew Bob well, you may have found that he did not show his emotions much. Navy Seals cannot let their emotions get in the way of what they do. The dropout rate in Navy Seal School approaches

93%. To do what Navy Seals do takes more guts than most of us can even imagine having.

I spent many nights in far away places with Bob hearing stories about his years as a Seal. As you can guess, best friends tell their buddies things that no one else will ever know. When Bob left us, he took with him things about me that my wife Cindy will never know, and I know things about Bob that no one else will ever know.

Bob lived a full life with more experiences than most 10 people combined. There was one experience; however, that Bob never really had. It was one that I could not be a part of or give him. Bob always had a girlfriend being the man that he was, and guess who heard all the stories about his relationships on those long nights and long voyages over the ocean and in the air. You ladies have heard your husbands or male friends say the words "You are the only one," but there is always that little question in the back of your mind. Is he really telling the truth or is it just because he loves me and wants to make me feel special? Well, when Bob met his beautiful wife Catherine, I am sure he may have told her that she was the one and only real love of his





life. Knowing that he usually did have a woman in his life, she had to wonder. She certainly knew he loved her dearly, but was there ever another woman that he may have been in love with. I can now assure her that his words were true. I know that only Catherine gave him the one experience that he lacked in his life. That was the experience of being so deeply in love. There was no other woman in his life who stole his heart like Catherine did. And I thank her for giving my best friend what no one else ever could. So, you see, my story was not about his adventures. It is a story about true love.

When I fly now and as I did so many times in the past, I look out beyond my wing where he always was when I needed some assurance that all was fine. I will never find anyone else to replace him in my life. The friends of Bear Lake have lost a dear friend as we all have. Bob, we will always remember, miss and love you.



The following Lakewatch data covers the last 10 months. Clarity level is the average of four locations on Big Bear Lake and three locations on Little Bear Lake and Cub Lake. Lake levels determined by surveyed elevation markers set on the lakes by Seminole County.

We are seeing pieces of hydrilla as well as broken pieces of eel grass floating up on our shorelines. What should we do?

- Rake it out and put it on your shrubbery, it is free fertilizer.
- Fragments of hydrilla can reproduce new plants, choking waterways.
- Broken off aquatic plants release nutrients into the water, pull them out, as algae loves to attach to them creating an ugly mass
- The broken pieces of plants create more algae which makes our lakes green!
- Keep grass clippings out of the lakes. They also create nutrients for algae to feed on.


