## **BLPA ALUM PROJECT**

Our lake's clarity has steadily declined since the late 1990's from an average of 15', adjusted for seasonal variations. <u>Now it is only at 5 FEET!</u> **IT IS TIME TO TAKE ACTION!** 

Alum (aluminum sulfate) is a nontoxic liquid that is commonly used in water treatment plants to clarify drinking water and is the same thing you buy at the grocery store spice rack for making pickles and other edible foods. It will not harm our fish or bird population. As the "floc" (fine captured particles) settles, the unwanted particles separate and settle to the bottom, leaving the lake noticeably clearer.

One low cost dose of alum will instantly double our water clarity! That kind of water clarity should boost or help maintain our property values. And not just the values of the lakefront residents either, the value of property with deeded access, and those in the entire watershed, and will help the Bear Lakes retain their reputation for being some of the cleanest lakes in Central Florida.

Alum is a safe and effective method to mitigate excess phosphorus in lakes and reservoirs. NALMS Position:

1. Alum is a safe and effective lake management tool.

2. Alum applications should be designed and controlled to avoid concerns with toxicity to aquatic life.

3. Watershed management is an essential element of protecting and managing lakes.

In cases where watershed phosphorus reductions are neither adequate nor timely, alum is an appropriate tool to accomplish meaningful water quality objectives.
